Park Models:

- Park Model Recreational Vehicles are a place for shelter, sleeping, cooking, eating and other occupation typical of what is commonly understood as being that of a living quarters for a period of not more than Six (6) calendar months in a year.
- No more than one Park Model Recreational Vehicle shall be placed on a parcel
- Shall be hooked up to a properly maintained, state approved sewage system.
- Shall have a state approved water supply.
- Shall have a state certified electrical connection by a master electrician. (Wisconsin Act 63)
- Shall not be placed, hooked up, and used on any private parcel if a dwelling exists on that parcel.
- Hitches may be removed, but kept on the parcel. Axels must remain attached.
- May be tied down to the parcel to guard against wind damage.
- A fire number must be obtained from the Town of Clearfield Clerk.
- Driveways must comply with the Town of Clearfield's zoning and building ordinance.
- No additions, auxiliary buildings or any other types of structures shall be attached or affixed to park model recreational vehicle, except skirting around the perimeter.
- No decks shall be attached or affixed to the park model recreational vehicle, except if the deck is standard equipment on the park model recreational vehicle. All structures shall comply with section 3.8 of ordinance 33.
- Compliance to the Town of Clearfield's zoning ordinance 25 sections 4.4, 5.3(1), 5.3(2) & 5.3(7), other sections may apply.
- Other permanent structures require a building permit, Town of Clearfield's Building Ordinance 7.

Recreational Camper Vehicles (Year Round Camping):

- Recreational Camper Vehicles are a place for shelter, sleeping, cooking, eating and other occupation typical of what is commonly understood as being that of a living quarters for a period of not more than Six (6) calendar months in a year.
- Shall have a state certified electrical connection by a master electrician. (Wisconsin Act 63)
- If the camper vehicle is connected to a state approved septic system, section 3.5 of ordinance 33, "Porta Potties" and "Composting Toilets" do not qualify.
- A fire number must be obtained from the Town of Clearfield Clerk.
- The Camper Vehicle needs to maintain registration with the DOT, described in section 3.4 of ordinance 33.
- A camper permit shall be filed with the Clerk every year by April 1st.
- No structures shall be affixed or attached to the Camper Vehicle, described in section 3.4(C) and section 3.8 of ordinance 33.
- Driveways must comply with the Town of Clearfield's zoning and building ordinance.
- The wheels or similar devices for transportation of any camper vehicle shall not be removed except for repairs lasting no more than ten (10) days.
- A camper vehicle shall not be permanently attached to the ground or to another vehicle or any auxiliary structure in any manner which would prevent the ready removal and transport of the camper vehicle.
- Compliance to the Town of Clearfield's zoning ordinance 25 sections 4.4, 5.3(1), 5.3(2) & 5.3(7), other sections may apply.
- Other permanent structures require a building permit, Town of Clearfield's Building Ordinance 7.

Recreational Camping Vehicles (Seasonal camping):

- Recreational Camper Vehicles are a place for shelter, sleeping, cooking, eating and other occupation typical of what is commonly understood as being that of a living quarters for a period of not more than thirty (30) calendar days in a year.
- Camping from April 1st to December 1st
- Recreational Camper Vehicles may only remain on the property for thirty (30) days in a twelve (12) month period.
- Other permanent structures require a building permit, Town of Clearfield's Building Ordinance 7.

Special Events:

- Recreational Camper Vehicles are a place for shelter, sleeping, cooking, eating and other occupation typical of what is commonly understood as being that of a living quarters for a period of not more than fifteen (15) consecutive calendar days in a year, not to exceed thirty (30) days in a twelve (12) month calendar period.
- Camping from April 1st to December 1st.
- Recreational Camper Vehicles may only remain on the property for fifteen (15) days in a twelve (12) month period.
- Other permanent structures require a building permit, Town of Clearfield's Building Ordinance 7.
